### **POLL RESULTS OF THE 2020 ANNUAL GENERAL MEETING HELD ON 29 SEPTEMBER 2020**

The board (the “**Board**”) of directors (the “**Directors**”) of Kwan On Holdings Limited (the “**Company**”) is pleased to announce that all the resolutions as set out in the notice (the “**Notice**”) of annual general meeting of the Company dated 3 September 2020 were duly passed by the shareholders of the Company (“**Shareholders**”) by way of poll at the annual general meeting of the Company held on 29 September 2020 (the “**2020 AGM**”).

As at the date of the 2020 AGM, the total number of ordinary shares of the Company in issue (“**Shares**”) was 1,584,000,000, being all the Shares which entitled the Shareholders to attend and vote for or against the resolutions proposed at the 2020 AGM. None of the shareholders were required to abstain from voting at the 2020 AGM under the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”). In addition, there were no Shares entitling the holders to attend and abstain from voting in favour of any resolution at the 2020 AGM as set out in Rule 13.40 of the Listing Rules. No parties had stated in the circular of the Company dated 3 September 2020 that they intend to vote against or to abstain from voting on any resolution at the 2020 AGM.

Tricor Investor Services Limited, the branch share registrar and transfer office of the Company in Hong Kong, was appointed as the scrutineer at the 2020 AGM for the purpose of the vote-taking.
