The Group is principally engaged in the provision of (i) waterworks engineering services; (ii) road works and drainage services and site formation works; (iii) landslip preventive and mitigation works to slopes and retaining walls services; and (iv) building works as a contractor in Hong Kong. The Board believes that the proposed Transfer of Listing will improve the liquidity of the Shares and enhance the profile of the Group. The Board considers that the proposed Transfer of Listing will be beneficial to the future growth and business development of the Group as well as its financing flexibility. There is no intention of the Board to change the nature of business of the Group following the Transfer of Listing. The Transfer of Listing will not involve issue of any new Shares by the Company.
